TOUR PROPERTIES LOCATED AT 2821 HILLCREST AND 2817 HILLCREST IN THE LOCKHOMA ADDITION CONCERNING REZONING APPLICATION NO. RZ-832 AND COMPREHENSIVE PLAN AMENDMENT NO. 11 FILED BY RICHARD MONTGOMERY, AND REZONING APPLICATION NO. RZ-837 AND COMPREHENSIVE PLAN AMENDMENT NO. 13 FILED BY CHRIS RAPRICH.

The City Council was transported to the Lockhoma Addition to tour the area of Poplar, Woodlawn, and Hillcrest Drive. Rezoning Applications RZ-832 and RZ-837, filed by applicants Richard Montgomery and Chris Raprich, were tabled from the February 2, 2009 City Council meeting along with their companion items following a protest from the residents of Hillcrest Drive. The homeowners in the area were opposed to the property being rezoned to a C-5 zoning district versus the current single-family residential zoning district. The Council elected to tour the property in order to make a more informed decision about the applications since the area contained a wide variety of uses from residential homes to salvage yards.
