## **Plaza Towers Water Line Replacement**

The City of Moore proposes the replacement of water line in the Plaza Towers Neighborhood in Moore, Oklahoma, Cleveland County. The water lines that will be replaced run along SW 5<sup>th</sup> to Penn Lane, then from Penn Lane to SW 10<sup>th</sup> Street. The water lines that run along Newport Avenue and SW 10<sup>th</sup> Street will also be replaced. The length of water lines to be replaced is 3,750 feet and the size of the water lines is eight inches. The proposed project site is located within AE Zone, as indicated on the Flood Insurance Rate Map (FIRM). The site also runs parallel with a riverine wetland.

The construction will take place outside of the horizontal limits of the 100 year floodplain where the water line is currently located.


