

# Section One

No fee shall be charged for using any park, except for use of special facilities such as but not limited to; the Community Center, pavilions, etc., further provided all such fees must meet prior approval of the Moore City Council **Fee Schedule** 

#### Section Two

No unauthorized person shall injure, disturb or remove any flora or fauna (plants or animals). No unauthorized person shall disturb or remove surface or subsurface materials **Sec. 10-316** 

#### Section Three

No person, other than City Personnel, may disturb, remove, or erect park buildings, structures or signs. No person shall advertise or place advertising in or upon park property without prior approval of the City Council Sec. 12-195 – 12-198

#### **Section Four**

No person shall litter a park. It shall be unlawful and an offense for any person to throw, drop or cast any bottle, jug or other container which is breakable and suited to holding any liquids on the streets, alleys, sidewalks, or parks of the City **Sec. 8-502; Sec. 10-322**

# Section Five

No person shall bring, possess, or permit a dog to enter or remain in the park unless it is caged, leashed, confined in a vehicle, or otherwise restrained, so as to be under the direct physical control of a person (verbal control not implied) Any dog or animal found running loose in any City Park or which chases or runs game may be removed to the Animal Shelter by the City of Moore Animal Control Officer or any Park Department employee. All dogs must be vaccinated and dog owners must carry proof of date and type of vaccination for dog(s) in his possession. No person shall allow an animal to be noisy or distract others. Sec. 11-116

#### Section Six

A "Seeing Eye" dog used to guide a blind person while using city park facilities is excluded from the provisions of Section 5 above. Federal Law

## Section Seven

No person shall carry or possess at firearm, a bow and arrow, or air or gas weapon or any device capable of injuring or killing any person or animal or damaging any public or private property, except in designated target or archery areas, or unless otherwise authorized by the City Council. Sec. 10-405 – 10-407

#### Section Eight

No fireworks shall be possessed or discharged in any City Park unless otherwise authorized by the City Council. Sec. 10-329

#### Section Nine

No person shall use threatening, abusive, boisterous, insulting, profane, indecent, or obscene language or indecent gestures in a City Park or facility. **Sec. 10-401** 

# Section Ten

No person may violate posted closing times for any park facility or area. The park will be closed from 12:01am to 6:00am. Sec. 11-113A

#### Section Eleven

No person shall conduct or participate in a disorderly assemblage. **Sec. 10-404** 

#### Section Twelve

No person shall be nude, lewd, or crude. Sec. 10-511

## Section Thirteen

No wastewater or sewage shall be deposited directly upon the ground or into drinking water. **MPWA** 

### **Section Fourteen**

No person shall consume or inhale any intoxicating substance of any kind in any park or park facility. Beverages containing 3.2% or more alcohol by weight is considered intoxicating for the purpose of this section. **Sec. 3-212; 10-501; 10-504** 

# Section Fifteen

No person shall consume or possess beer in a City Park without prior approval by the City Council. For the purpose of the section, any beverage with 3.2% alcohol by weight is considered beer. Sec. 3-212

#### Section Sixteen

No person shall use, sell, possess, or distribute botanical genus Cannibas and derivatives (i.e. marijuana) on any City Park property. Also, opium and other narcotics may not be illegally furnished, sold or provided to individuals while on City property. Sec. 10-502 – 10-503

# Section Seventeen

No person shall solicit or sell any goods, wares, merchandise, liquids or edibles for human consumption in a City Park or facility, except by concession privileges granted by the Moore Park Board. Sec. 8-601 - 8-618

# Section Eighteen

No person shall drive a vehicle in a City Park at a speed greater than posted, having due regard for traffic conditions, the surface and width of the road, and in no event as a speed which endangers the safety of persons, property or wildlife. Sec. 15-701 – 704

# Section Nineteen

Any peace officer with concurrent jurisdiction in a City Park is authorized to cause the removal of a vehicle from the park under the provision of the Codes and Ordinances of the City of Moore. **Sec. 8-401 – 8-418** 

# Section Twenty

No vehicles may be parked in a City Park in unauthorized parking areas. No City Park parking lot can be used for private or residence parking. Sec. 8-401 – 8- 418

# Section Twenty-One

No horse or other animal may be ridden or allowed in unauthorized areas of any City Park. Sec. 11 – 116

#### Section Twenty-Two

All rules and laws applying to the operation of vehicles shall apply to the operation of bicycles, skateboards, and other wheeled vehicles, except those that by their nature can have no application. A person operating a bicycle upon a roadway shall ride as near to the right side of the roadway as practical, exercising due care when passing a standing or moving vehicle. Bicycles shall not be ridden or driven more than two abreast, except under supervised events. No bicycles or other wheeled vehicles are allowed on maintained playing fields at any time. # Section Twenty-Three

No person shall camp in a City Park. Sec. 11-113

#### Section Twenty-Four

No motorized vehicle shall be permitted on any municipal park grounds except vehicles operated by or authorized by park or city officials. Mini-bikes, three wheeled bikes, or dirt bikes shall be considered motorized vehicles. Sec. 11-112
