WHEREAS, the Action Plan meets all current planning and application requirements of the Community Planning and Development Programs funded by the U.S. Department of Housing and Urban Development; and

WHEREAS, the consolidated programs include Community Development Block Grant; Home Investment Partnership program, Emergency Shelter Grants and Housing Opportunities for Persons with AIDS; and

WHEREAS, the City of Moore has conducted public hearings and has received public input concerning the development of the CDBG-DR Action Plan and otherwise informed residents of the proposed plan of activities and budget levels.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Moore, Oklahoma, as follows:

The City Council has reviewed the amended Action Plan for the Community Development Block Grant-Disaster Recovery Program projected use of funds and find it to be consistent with the overall objectives of the Housing and Community Development Act and local neighborhood redevelopment strategies, and authorize the Mayor to submit to the Department of Housing and Urban Development.

## **Summary of Changes**

Substantial Amendment #8 (SA) modifies the City of Moore's Community Development Block Grant Disaster Recovery action plan of 2014 as follows:

HUD determined the GIS update and server planning activity did not comply with 24 CFR 570.205 and concluded the activity was ineligible in August of 2019. A repayment plan for the CDBG-DR funds used for the activity was accepted by HUD in May of 2020. The repayment plan consists of four payments that will be made during a two year time period. The funds will be reallocated to the infrastructure program. Three infrastructure activities have been identified that will be funded with these reallocated funds.

The City proposes the following infrastructure activities, all of which are identified in the IRIP:

- Plaza Towers water line replacement: Estimated budget \$172,500.00
- Baer's Westmore sewer line replacement: Estimated budget \$300,000.00
- Eastmoor sewer line replacement: Estimated budget \$213,000.00

# **Proposed Projects Summary:**

### Return of Funds to Grant

All planning activities are complete. The SA reallocates funds for the repayment of the GIS Update and GIS Server planning activities that were determined to be ineligible to the infrastructure project. The total amount reallocated from planning is \$589,350.00.

### Re-Allocation of Returned Funds

The SA updates the infrastructure needs assessment based on current data, and adjusts the budgets by allocating funding from planning to infrastructure. The total amount reallocated to infrastructure is \$589,350.00.

# 1. Planning

The City has determined that its planning needs have been met and has completed ten planning projects. The city has updated its comprehensive plan, produced a stormwater management and drainage plan, completed a feasibility study for a debris barrier wall, and produced a capital improvements plan, all of which were identified in the action plan. There are no other outstanding planning needs.

#### 2. Infrastructure

In accordance with Federal Register Notice (FRN) FR-5696-N-01: *Allocations, waivers, and alternative Requirements for Grantees Receiving Community Development Block Grant Disaster Recovery Funds in Response to Disasters Occurring in 2013; (March 5, 2013),* the city procured Cardinal Engineering to complete an Infrastructure Recovery and Implementation Plan (IRIP) in order to assess community impacts, identify unmet needs, and plan and prioritize recovery activities. The IRIP refined original damage estimates, and identified needed public infrastructure improvements that totaled \$162 million. Forty-seven projects that encompass 158 sub-projects within the tornado were identified.

The city has completed 13 of the identified infrastructure activities; restoring and constructing damaged roadways and sidewalks, repairing and constructing sewer and water systems, and rebuilding public parks. Two identified infrastructure activities are currently underway, Little River Park Drainage Improvements and S. Janeway Avenue Street Replacement.

Because of the amount of unmet need that still exists for infrastructure, the City determined the funds that will be repaid would be best reallocated for infrastructure activities. Since several street repair/replacement activities have already been completed, the City's Project Supervisor for infrastructure activities determined water and sewer lines should be addressed with these funds. The City's Utility Director identified infrastructure activities that could be funded with the reallocated planning funds using the following criteria:

- 1. What activities could be completed in concurrence with the repayment plan and the expenditure deadline of September 30, 2022
- 2. The cost of the activity
- 3. Amount of water main breaks in the area
- 4. Amount of repairs made to the lines since the disaster



The following activities were all identified in the city's Infrastructure Recovery and Implementation Plan (IRIP): Plaza Towers water line replacement, Baer's Westmore sewer line replacement, and Eastmoor sewer line replacement. These projects were listed in Amendment #1 to the City of Moore's CDBG-DR Action Plan. Appendix J of Amendment 1 consists of data from the IRIP that includes identified infrastructure activities that all tie back to the disaster. Plaza Towers Water line can be found on pages 326-327 of Amendment 1(pages 45-46 Appendix

J), Eastmoor Sewer line can be found on pages 160-161 of Amendment 1 (pages 13-14 Appendix J), and Baers Westmore Sewer line can be found on pages 154-155 of Amendment 1 (pages 7-8 Appendix J). All three of the activities are located in the disaster area.

Water and Sewer lines unmet need was initially established on page 37 of the Action Plan in Table 11. It was further defined with the completion of the IRIP, included in Amendment 1, with water and sewer lines identified as one of the seven general infrastructure categories assessed in the IRIP. Water and Sewer lines received significant damage from the tornado from debris and redevelopment. As maintenance is performed on the lines, debris has been found causing cracks and decrease of flow in the lines.

Construction will start on these activities once enough funds have been repaid for the ineligible expenditure of the GIS update. Plaza Towers water line replacement is estimated to start in the summer of 2021 and Baer's Westmore sewer line replacement and Eastmoor sewer line replacement is estimated to start in the summer of 2022. Construction completion for each activity is expected to be one month from the start date.

#### *Infrastructure Activities*

The following table is a summary of infrastructure activities. Thirteen of the activities have been completed, two are in progress, and three are proposed activities identified above.

#### (A) Public Comment

Public Notices for the substantial amendment were published in The Oklahoman and El Latino newspapers. Public Notices were also be posted at the Moore Public Library, The Brand Senior Center, and on the city's website, <a href="www.cityofmoore.com">www.cityofmoore.com</a>. The draft substantial amendment can be viewed on the City of Moore website or in person at the Capital Planning & Resiliency Department at Moore City Hall, 301 N. Broadway Ave, Moore OK 73160. Public comments on the proposed used of funds were accepted from September 3, 2020 through October 5, 2020. Comments could be submitted in writing to <a href="cdbg@cityofmoore.com">cdbg@cityofmoore.com</a> or call the Capital Planning & Resiliency Department at 405-793-4571.

The draft substantial amendment was presented to city council at a public hearing on October 5, 2020 at 6:30 pm. The meeting was held at Moore City Hall in the city council chambers, 301 N

Broadway Ave, Moore, OK 73160. Citizens were provided the option of attending the public hearing and provide comments on the proposed substantial amendment virtually via Zoom. Citizens were asked to contact the Capital Planning and Resiliency Department at 405-793-4571 to make these arrangements.

The City of Moore encourages participation from all its citizens. If participation at any public meeting is not possible due to a disability (such as a hearing or speech disability) or a language barrier, notification to the City Clerk at least forty-eight (48) hours prior to the scheduled public meeting is encouraged to allow the City to make the necessary accommodations. Time was allowed during the public hearing for public comment. No comments were received during the public hearing. No comments were received during the thirty day comment period.
