Non-Substantial Amendment #11 reflects the changes made to the allocations in Round 1, Round 2, Round 3, and Round 5 Extension. The City completed a review on planning and housing projects. During the review, a total of \$9,696.75 in ineligible costs resulting from cost plus language in contracts were discovered for the following activities and funding rounds: R1 –P-00, R2 – H-02-W-LMI, R2 – H-03-E-LMI, R2 – H-04-W-LMI, R3 - H-04-W-LMI, and R2 - I-20-W-URG. The City will correct the draws that contain the ineligible costs by applying current eligible costs using voucher revisions. This correction will not impact any program or activity benefits. These ineligible costs are being paid by City funds and not with federal funds.

The eligible costs applied are \$7,288.72 in administrative and \$2,408.03 in infrastructure expenditures. Therefore, the housing project in Rounds 2 and 3 and the planning project in Round 1 budgets will decrease, and the administrative and infrastructure budgets in the same rounds will increase, as shown in Table 2. The administrative budget in Round 5 Extension will decrease to compensate for the increase in the Round 1 and Round 2 administrative budget, thereby maintaining compliance with the 5% administrative cap.
