Public Hearing for a Substantial Amendment to the 2019 Community Development Block Grant (CDBG) Action Plan

Community Public Hearing: December 7, 2020, 6:30 pm, City Council Chambers, 301 N. Broadway.

The City of Moore has been allocated additional Community Development Block Grant COVID-19 (CDBG-CV) Funds from the Department of Housing and Urban Development (HUD). The CDBG-CV funds have been appropriated by *The Coronavirus Aid, Relief and Economic Security Act (CARES Act)*, 2020 (Pub. L. 116-136). CDBG-CV funds are to be used to prevent, prepare for, and respond to COVID-19. On September 11, 2020, the Department of Housing and Urban Development allocated Community Development Block Grant funds in the amount of \$294,687 to the City of Moore in order to assist in the prevention, preparation for, and response to the Coronavirus (COVID-19). The City proposes an amendment to its 2019 CDBG Action Plan to include the allocation of the CDBG-CV funds.

A public hearing will be held during the Moore City Council meeting on Monday, December 7, 2020, at 6:30pm in the Moore City Council Chambers, City Hall, 301 N. Broadway, Moore, OK 73160. The hearing will allow interested citizens to ask questions and comment on the City of Moore's Substantial Amendment to the 2019 CDBG Action Plan.

The substantial amendment will be available to the public for review and comment from November 30, 2020 through December 7, 2020.
