Judge Blake Virgin administered the Oath of Office to Sid Porter as the newly appointed Councilman for Ward 3.

Mayor Hamm presented a proclamation to Carolyn McCade declaring September 17-23, 2024 as "Constitution Week" in the City of Moore. Ms. McCade accepted the proclamation on behalf of the Moore Malcom Hunter Chapter of the Daughters of the America Revolution.

Steve Whitlock, Executive Director of the Oklahoma Association of Chiefs of Police ("OACP"), advised that The Village Police Chief Russ Landon, and Edmond Police Chief and current President of the OACP, J.D. Younger were also in attendance. Mr. Whitlock presented awards on behalf of the Oklahoma Association of Chiefs of Police. He presented Sergeant Kent Dunbar with a commendation for his service on the Police Department's drone team. Sgt. Dunbar was instrumental in leading the team to higher levels of training and in receiving advanced state-of-the-art equipment, technology, and flight trafficking software. Mr. Whitlock stated that without Sergeant Dunbar's dedication and drive the drone program would not be what it is today.

Mr. Whitlock then presented the Large Agency Chief of the Year award to Police Chief Todd Gibson. He explained that the award is given by the OACP to members who serve a population over 15,000 and who distinguish themselves by commendable service. He stated that Chief Gibson was hired into the Moore Police Department in 2020 just in time to lead his department through a global pandemic. Since that time his leadership has had a huge impact on the culture of the department. He established a navigational guide that has led his department through tough times in law enforcement. Chief Gibson created a great relationship with the officers and with the community. One of his most impactful changes was to switch to a geographical policing system. He has increased training with officers in overall community involvement. He hired a mental health liaison that he shares with other departments. His goal is to make the Moore Police Department the premiere department in the State of Oklahoma. In a short time, he has done a great job in motivating the officers to perform their jobs with pride and integrity. The OACP cannot think of a more deserving person to be named as 2024 Large Agency Chief of the Year than Chief Gibson. After Chief Gibson and Sgt. Dunbar accepted their awards, Mayor Hamm congratulated them for the honors they received.

Mayor Hamm presented a letter of appreciation and a trophy to Don Snow for 25 years of service on the Moore Planning Commission and to the family of Kent Graham for his 19 years of service on the Moore Planning Commission. Mayor Hamm was pleased to honor the commissioners for volunteering their time to serve the community. He stated that their job is difficult and he is happy to recognize them for their hard work, dedication, and commitment to the City. Mayor Hamm ended his presentation by expressing his condolences to the family of Kent Graham who recently passed away.

#### Agenda Item Number 3 being:

DISCUSS AND CONSIDER APPROVAL OF THE MOORE PUBLIC TRANSPORTATION FEASIBILITY STUDY.

Kahley Gilbert, Project-Grants Manager, advised that Shawn Strate, Lead Project Manager with Olson and Associates, would be making his final draft presentation on the Moore Public Transportation Feasibility Study over Zoom. After discovering there was an audio problem a short break occurred while staff attempted to locate and correct the issue.

Mayor Hamm took the opportunity to welcome Representative West and Representative Elect Jason Blair to the meeting. After a short time, Mayor Hamm announced that Council would move forward with the agenda while staff continued to work on finding a solution to the audio problem. The item was ultimately heard following Agenda Item No. 10.

#### Agenda Item Number 4 being:

RECEIVE PROPOSAL FROM THE CITY'S RETIREMENT PLAN ADVISOR, STEVE CONKIN.

Steve Conkin with Conkin Financial Group stated that he is assisting the City on the retirement plan. Mr. Conkin advised that he would be giving an update on what has happened over the past year and a half and to make a recommendation on where to go in the future.

Mr. Conkin stated that during the spring of 2023 the City solicited bids for vendor replacement for the 401A and 457B plans currently administered by Empower Retirement. Bids were received from Voya, Nationwide, Ascensus, Ameritas, and The Standard. He stated that one bid was rejected because the company could not provide all the services requested. Two more bids were rejected because they were higher than the current vendor. The remaining bids from Voya and Nationwide were reviewed and the companies invited to do in-person finalist presentations held in January 2024. Mr. Conkin indicated that both companies had very similar pricing structures. He stated that ultimately it came down to which company spoke more about assisting the employees with their retirement goals, marketing, and educational efforts. Voya appeared to be very focused on those things; therefore, the recommendation is to change the plan's recordkeeper from Empower to Voya. He stated that ideally this would be a four-month endeavor.

In addition to hiring Voya as the recordkeeper, Mr. Conkin recommended hiring a new Third-Party Administrator or TPA. The TPA will approve loans and distributions as well as draft Plan documents. Plan documents refer to the legal documents that create the Plan. Mr. Conkin advised that Empower is currently both the recordkeeper and the TPA. He felt that having the same company running the assets that created the rulebook would be a conflict of interest and recommended that the two functions be separated. The sole responsibility for Voya would be creating the website, custody of the assets, sending out the checks, and manning a 1-800 number. The TPA will create the documents that run the Plan. Mr. Conkin stated that if Council is agreeable staff would present contracts for consideration in October or November 2024 with implementation anticipated to take place in January 2025.

Brooks Mitchell, City Manager, stated that implementation would take place in January 2025 to prevent confusion over receiving documents from two retirement plan advisors. Mr. Mitchell noted that the purpose of the presentation was to give an update on the process and answer any questions from Council.

#### Agenda Item Number 5 being:

CONSIDER APPROVAL OF A NEW JOB DESCRIPTION FOR COMMUNICATIONS OFFICER TRAINING COORDINATOR IN THE POLICE DEPARTMENT'S COMMUNICATIONS DIVISION AT THE PUBLIC SAFETY CENTER AND ASSIGN IT TO PAY GRADE 111 OF THE SALARY TABLE APPROVED BY CITY COUNCIL ON JUNE 20, 2016 AND IN ACCORDANCE WITH THE BUDGET APPROVED BY CITY COUNCIL FOR FISCAL YEAR 24-25.

Christine Jolly, Human Resources Director, stated that the Police Department requested approval of a new full-time budgeted job position and description for Communications Officer Training Coordinator. Job duties include planning, organizing, and coordinating orientation and training for emergency response dispatch employees and implementing and updating approved changes to the training manual. This employee would also perform the regular duties of a dispatcher by dispatching emergency and non-emergency calls for service.

Councilman Webb moved to approve a new job description for Communications Officer Training Coordinator in the Police Department's Communications Division at the Public Safety Center and assign it to Pay Grade 111 of the June 20, 2016 salary table, second by Councilman Wiliams. Motion carried unanimously.

#### Agenda Item Number 6 being:

CONSIDER APPROVAL OF THE BUDGETED REPLACEMENT OF CRACKED CONCRETE WALKING TRAIL PANELS AND INSTALLATION OF ADA-COMPLIANT BENCH LOCATIONS AT VETERANS MEMORIAL PARK, BY SILVER STAR CONSTRUCTION UNDER THE PUBLIC WORKS MAINTENANCE CONTRACT, IN THE AMOUNT OF \$28,887.68.

Sue Wood, Parks and Recreation Director, stated that the agenda item was for replacement of old and cracked concrete sidewalk areas with new concrete for new ADA compliant benches at Veterans Park.

Councilman Webb moved to approve the budgeted replacement of cracked concrete walking trail panels and installation of ADA-compliant bench locations at Veterans Memorial Park, by Silver Star Construction under the Public Works Maintenance Contract, in the amount of \$28,887.68, second by Councilwoman Griffith. Motion carried unanimously.

#### Agenda Item Number 7 being:

CONSIDER APPROVING AN AGREEMENT WITH PINNACLE CONSULTING MANAGEMENT GROUP, INC., IN THE AMOUNT OF \$346,500 FOR RIGHT-OF-WAY ACQUISITION SERVICES FOR THE BROADWAY AVE. (SE 19TH STREET TO WILLOW PINE) AND EASTERN AVE. (SE 19TH STREET TO BROADWAY AVENUE) RECONSTRUCTION PROJECTS.

Jerry Ihler, Assistant City Manager, stated that the proposed agreement with Pinnacle Consulting Management Group is a standard right-of-way acquisition agreement for two 2023 GO Bond projects located on Broadway Avenue from SE 19<sup>th</sup> Street to Willow Pine, and Eastern Avenue from SE 19<sup>th</sup> Street to Broadway Avenue. He indicated that 36 parcels are included in the two projects. Mr. Ihler advised that

the projects may be divided into two or three phases; however, right-of-way acquisition will be performed under one contract and would include title research, ROW staking, appraisals, and right-of-way acquisitions.

#### Citizens to Speak:

Linda Howard, 3115 S. Broadway, expressed her fear that the new street would end up at her door and was concerned about her grandchildren's safety while outside. Jerry Ihler, Assistant City Manager, stated that the engineering on the project was 90% complete. Ms. Howard asked how far from a major street a residence should be located. Councilman Williams stated that Elizabeth Weitman, Community Development Director, was not at the meeting to respond to the question; however, but it was his understanding that on major thoroughfares a house must be located 50' from the centerline of the roadway to the right-of-way. Mr. Ihler advised that staking hasn't taken place yet but estimated that Ms. Howard's house would be 52' to 53' from the centerline of the 4-lane road. Mr. Ihler indicated that he had sent some additional information that had just become available to Ms. Howard's daughter, Patrice Williams, which contained a legal description, drawing, and right-of-way acquisition. He noted that the 10' pedestrian trail is also on Ms. Howard's side of the street. Councilman Webb suggested that if Ms. Howard's property was the only one affected maybe a solution could be found such as erecting a barrier of some sort.

Mayor Hamm suggested tabling any further discussion until the engineering and staking was complete so Council has a better understanding of what the footprint would be. Mr. Ihler also offered to sit down with Ms. Howard after the plans were complete to go over her concerns. Mayor Hamm asked that the City Council be kept apprised of the situation.

Patrice Williams, 1061 NW 6<sup>th</sup> Street, stated that it was also her understanding that the roadway would come up to her mother's front door.

Councilman Williams moved to approve an agreement with Pinnacle Consulting Management Group, Inc., in the amount of \$346,500 for right-of-way acquisition services for the roadway Ave. (SE 19th Street to Willow Pine) and Eastern Ave. (SE 19th Street to Broadway Avenue) Reconstruction Projects, second by Councilwoman Griffith. Motion carried unanimously.

#### **Agenda Item Number 8 being:**

CONSIDER APPROVAL OF A CONSTRUCTION AND MAINTENANCE AGREEMENT BETWEEN THE BNSF RAILWAY COMPANY AND THE CITY OF MOORE AND THE OKLAHOMA DEPARTMENT OF TRANSPORTATION FOR CONSTRUCTION AND MAINTENANCE OF THE SE 4TH STREET RAILROAD UNDERPASS PROJECT.

Jerry Ihler, Assistant City Manager, stated that the proposed Construction and Maintenance Agreement between the City, BNSF Railway Company, and ODOT states that any work that occurs on the tracks or shoo fly must be performed by BNSF or its subcontractors. The agreement includes the cost estimate and outlines the responsibilities for both the City and BNSF. Mr. Ihler advised that the City will be responsible for the total track work estimated to cost \$7.15 million, and the railroad will provide the labor. The Geotech support includes the railroad signing and signaling work, an on-site construction manager or project inspector, and a flag man to control the rail traffic. The total contract amount is \$8,004,623. Mr. Ihler stated that ODOT verbally agreed to increase their contribution from 10% to 50% of the remaining cost after subtracting ACOG funding, grant money, and congressional money. Mr. Ihler anticipated a new

contract would be coming soon that would reflect the new amount ODOT agreed to pay toward the project.

Councilman Williams asked how much of the track would be affected during construction. Mr. Ihler stated that because the speed limit changed from 55 mph to 88 mph the shoo fly will need to begin further away, approximately south of SE 4<sup>th</sup> Street, and end at Main Street.

Councilwoman Hunt moved to approve a Construction and Maintenance Agreement between the BNSF Railway Company, the City of Moore and the Oklahoma Department of Transportation for construction and maintenance of the SE 4th Street Railroad Underpass project, second by Councilman Williams. Motion carried unanimously.

#### Agenda Item Number 9 being:

CONSIDER APPROVAL OF AN EASEMENT AGREEMENT BETWEEN THE BNSF RAILWAY COMPANY AND THE CITY OF MOORE AND THE OKLAHOMA DEPARTMENT OF TRANSPORTATION REGARDING THE SE 4TH STREET RAILROAD UNDERPASS PROJECT.

Jerry Ihler, Assistant City Manager, stated that the proposed easement agreement between BNSF Railway Company, the City of More, and the Oklahoma Department of Transportation addresses construction and maintenance of the project in the future. The railroad is granting the City an additional 6' easement on the north side for the width of the roadway project and an additional 10' on the south side for the entire width of the railroad right-of-way at no cost.

Councilwoman Hunt moved to approve an Easement Agreement between the BNSF Railway Company and the City of Moore and the Oklahoma Department of Transportation regarding the SE 4th Street Railroad Underpass project, second by Councilman Williams. Motion carried unanimously.

Kahley Gilbert, Project-Grants Manager, advised that there were still technical difficulties with the audio; therefore, Shawn Strate, Lead Project Manager, with Olson and Associates would be making his presentation by utilizing a speakerphone.

Mr. Strate stated that he presented some alternatives and recommendations in June 2024 as part of the Moore Public Transportation Feasibility Study. He is now seeking approval and adoption of the final plan. He advised that the purpose of the plan was to evaluate opportunities for accessible transit service for everyone in the City and to develop implementation plans for the service. Three alternatives for public transportation were reviewed:

- 1. Citywide On-Demand Micro Transit Service:
- 2. Multiple Zones On-Demand Micro Transit Service This covers a smaller area based on areas where ridership and demand are most likely.
- 3. Flex Route This a hybrid between a fixed route bus and on-demand service with some flexibility built into it.

#### **Three Phases of Implementation:**

#### PHASE I:

1A: Expand demand response service provided by the Senior Center including a partnership with EMBARK Mobility Management programs.

1B: Citywide micro transit pilot service. The recommendation is to implement a turnkey service with a private vendor. The vendor would be responsible for providing all aspects of operating the service such as providing vehicles, drivers, and maintenance. The City would be responsible for oversight of the service such as ensuring the service is operating as planned and that it benefits the City.

PHASE 2 would include making adjustments to the service based on data collected.

PHASE 3 would implement a Flex Route service based on ridership data patterns. The Flex Route is a hybrid between a bus route and a service with scheduled stops but with flexibility.

#### **Phase 1 Implementation Timeline:**

Mr. Strate noted that the timeline can vary depending on the funding process; however, a service could potentially be operational by mid-2026 based on cities that have started similar services in the past. He stated that the plan is complete, and they are seeking Council adoption of the study. He suggested having detailed funding discussions particularly with EMBARK and ACOG as well as with potential regional and state partners. He stated that there will also be a need for a more detailed look at the Brand Senior Center costs and budgeting. Mr. Strate advocated engagement of the stakeholder group in the implementation process since they understand the needs of the City and can be a valuable resource.

Kahley Gilbert stated that staff was seeking approval of the Study but would like some guidance on the next phase. Staff recommended researching grant opportunities since some grants must be spread out regionally and it would be necessary to determine funding availability for Moore. Also, staff would recommend researching micro transit providers to get a more defined cost estimate.

Councilman Williams asked if a G.O. Bond would be necessary to fund the project since it appears to be around \$180,000 to \$200,000 for the first five years. Brooks Mitchell, City Manager, did not feel that a G.O. Bond would be required at this point. Mr. Mitchell stated that possible funding sources have presented themselves recently that he would like to discuss with the City Council in more detail.

#### Citizens to Speak:

Patrice Williams, 1061 NW 6<sup>th</sup>, felt that the study was saying that the Santa Fe North Addition was in the lowest poverty level in the City although the addition contained \$300,000 homes. Mayor Hamm stated that the area was very diverse with lower and higher income levels. Ms. Gilbert pointed out that the area is divided by an entire census tract.

Councilman Williams stated that the study was to make public transportation available to everyone in Moore and to give them the ability to go anywhere within the City.

The City Council of the City of Moore met in the Upstairs Conference Room, 301 North Broadway, Moore, Oklahoma on September 3, 2024 at 5:30 p.m. with Mayor Mark Hamm presiding.

RECEIVE A PRESENTATION FROM CANDICE MCINTIRE WITH THE OKLAHOMA DEPARTMENT OF VETERANS AFFAIRS AND NAVY MASTER CHIEF AND STATE COMMANDER FOR THE MILITARY ORDER OF THE PURPLE HEART LARRY VAN SCHUYVER REGARDING THE BENEFITS IN BECOMING A PURPLE HEART CITY.

Mayor Hamm announced that the Master Chief Van Schuyver was unable to attend the meeting due to a medical emergency. Candice McIntire with the Oklahoma Department of Veterans Affairs would be making the presentation on his behalf. Ms. McIntire advised that Carrie Moore, who sits with her on the Ambassador Panel of the Military Order of the Purple Heart, was accompanying her. Ms. McIntire stated that she is not a veteran but has a long history of veterans in her family. She thanked those individuals who are veterans and thanked the family members of veterans because they serve alongside the veteran in a different capacity.

Ms. McIntire spoke on the benefits in Moore becoming a Purple Heart City. She stated that both she and Ms. Moore are residents of Moore. She advised that Moore has 1.3 times more veterans than the City of Oklahoma City metro. She advised that 8.7% of the adult population are veterans. The Purple Heart is the oldest combat military decoration in the United States and was created by General George Washington in 1782. The purple heart is awarded to service members who have suffered a life altering injury or made the ultimate sacrifice in combat. To be named a Purple Heart City an official proclamation must be presented to the local Chapter of the Military Order of the Purple Heart. She noted that the proclamation could be presented to Master Chief Van Schuyver since he is the State Commander.

Ms. McIntire stated that the purpose in becoming a Purple Heart City is to express gratitude to the individuals living in our community who were either wounded or killed in combat defending the freedoms enjoyed by all Americans. There are more than 900 purple heart locations in the United States honoring the 1.6 million Purple Heart recipients. Ms. McIntire advised that on November 1, 2019, Governor Stitt made Oklahoma a Purple Heart State. There are more than 600 cities in Oklahoma that have been recognized as Purple Heart Cities. There are Purple Heart Universities and recently the Cheyenne Arapaho

Tribe became a Purple Heart Tribe. Ms. McIntire stated that they are still working to determine the number of purple heart veterans in Oklahoma; however, they estimate there is approximately 4,800. She advised that the Military Order of the Purple Heart goes beyond purple heart recipients of the military, they also honor police officers, firefighters, and first responders who were injured or killed in the line of duty. Living in Moore she is aware that Moore is very community driven with a sense of pride and support for the first responders.

Ms. McIntire stated that what it means when you became a Purple Heart City can be something as simple as designating a certain parking space at City Hall or the local tag agency. A lot of mayors encourage local businesses to do something special for purple heart recipients such as offer a free cup of coffee with breakfast, a 10% discount which some businesses offer to veterans anyway, a special coin that they order to give a purple heart recipient that comes in to shop or eat, or a decal on the window that says we are a veteran friendly community and that we recognize their sacrifice.

Fire Chief Herbster asked if a sign would be erected identifying Moore as a Purple Heart City. Ms. McIntire confirmed that signs are erected at each entrance into the City limits and paid for by the local Chapter of the Military Order of the Purple Heart. She stated that the only expense to the City would be for the cost of typing the proclamation and anything else the City decides to do. If the City of Moore becomes a Purple Heart City a plaque will be presented by Master Chief Van Schuyver who will likely coin everyone on the City Council. There would also be a picture opportunity if Council is agreeable to that.

Ms. Moore commented that she served five years in the Navy at the National Security Agency in Maryland. She stated that she is a veteran, her father was a Vietnam veteran, her husband is a Marine Corp Operation Iraqi Freedom veteran. Knowing veterans are in the community that have received extra training, like police and firefighters, can make the residents feel safer. Once you are out of the military you don't forget your training. Once you have served you are a servant, and you feel it is your duty to protect.

Ms. McIntire stated that if Moore decides to become a Purple Heart City it would be placed on a State and Federal Registry. Many times, veterans who are traveling check the registry and stay in locations that are a Purple Heart City.

Councilman Williams felt that Council should have a discussion and come up with an organized plan on how and where recognition can be placed, such as at Veterans Memorial Park, City Hall, and The Station.

Ms. McIntire thanked the City Council for their time and consideration.

Discuss and Consider the Fina Plat of Sonoma Lakes, Phase III, located in the SE/4 of Section 7, T10N, R2W, being North of NE 12th Street and West of Sunnylane Road. Application by Sonoma Development Group, LLC/Justin Rhodes. Ward 2.

Ms. Lauren Purcell, Assistant City Planner, gave the following presentation.

The subject site is located north of NE 12th Street and east of Bryant Ave. The property was rezoned from A-2 Suburban Agriculture to R-1 Single Family Residential and Preliminary Platted in 2012 for the development of the Sonoma Lakes Addition. The final plat for Sonoma Lakes Addition, Phase 3 consists of 43 residential lots on approximately 17 acres and includes 2 Common Areas: Common Area G and F. Common area G is to be used for stormwater drainage and common area F is an extension of Common area E, from Phase 2, for existing easements.

An 8" water and sewer main is available south of the site along Pendleton PI, NE 15th St., and Maclaren Ln in Section 2 of the addition. Water and sewer will be extended through Phase 3.

Access is available from Pendleton PI and Maclaren Ln as platted in Phase 2 of the addition.

A FEMA floodplain and floodway is located on the west side of the property. Because this phase of the development is under the 2021 Drainage Criteria regulations, the floodplain and floodway are contained in the proposed Common Area G, and the plat includes a 50' riparian buffer along the channel that is not included in the residential lots. Additionally, the development must account for the incremental increase in detention volume from the old drainage criteria to the 2021 Drainage Criteria.

The proposed Final Plat of the Sonoma Lakes Addition, Phase 3 development, varies from the approved Preliminary Plat by increasing the access points to Phase 2 and reserving the FEMA floodplain and floodway,

along with a 50' riparian buffer as required in the 2021 Drainage Criteria. These changes are considered improvements on the original design.

Staff recommends approval of the Final Plat.

Chairman Sherrard asked if there were the commission had any questions for staff. After no response, Chairman Sherrard asked if the applicant was present.

Anthony Hanley, with Crafton Tull, introduced himself as the engineer for the project representing the applicant. Mr. Hanley, stated, the Final Plat does deviate from the Preliminary Plat, however the Plat does comply with the 2021 Drainage Ordinance. Mr. Hanley offered to answer any questions.

Commissioner Lunow asked if the applicant agrees with all staff recommendations. Mr. Hanley, answered, yes.

Chairman Sherrard asked if there were any members of the audience who wished to address this issue. Hearing none, a motion was requested.

Gary Lunow motioned to recommend **Approval of the Fina Plat of Sonoma Lakes**, **Phase III**, subject to staff recommendations. Brandon Laib seconded the motion. Roll was called.

#### Agenda Item Number 3 being:

#### REVIEW OF MOORE GIRLS SOFTBALL ASSOCIATION

Sue Wood, Parks and Recreation Director, stated that she is concerned with some of the behavior of the Moore Girls Softball Association coordinator, Wes Williams, specifically problems getting information from them that is required per the agreement such as their 501(c)(3) status, their profit/loss reports and submitting 1099s.

Sue presented documents showing that Parks and Recreation tried to contact Wes in numerous ways and times regarding these issues; he was also asked to be present at this meeting due to the board having some questions for him regarding these items but he is not in attendance.

Secretary Mattocks asked if there is an in-house process to conduct an audit prior to this getting so far out of line. There has been several times that recommendations have come for us to authorize the extension of their lease and we did so in good faith, but now we find out that we have organizations that are years out of compliance. For the City's and the association's benefit there should be some kind of internal auditing process to make sure that they're up to date and current with the people that they're representing; someone who will be held accountable.

Chairman Porter asked if the issue is with a certain form that hasn't been filed. Sue responded that it's the 501(c)(3) that is being investigated. Chairman Porter asked if the other associations are up to date on their 501(c)(3). Whitney Wathen, Assistant Parks and Recreation Director, responded that the other associations either have their 501(c)(3) status or are in the process of getting it; all softball has to do is submit documentation that they're in the process of getting it.

Vice Chairman Payne noted that their 990 is dated 2015. Sue responded that we're just not getting the information from them. Board Member Vickers added that the federal document being from 2015 should have been brought to the board's attention before 2024 and the city and parks directors during this time period should have been notified; the city needs to do a better job on finding these things out.

Sue responded that Whitney has put together a form detailing the items needed from the associations as per the agreement and Holly Hackett, Sports Coordinator, will get these to the associations. Sue added that softball has been asked numerous times about submitting 1099s for their umpires and they have had full knowledge that we would be working with them to ensure that everything is done. Umpires for baseball that also umpire for softball asked about the why there are two different procedures when they have to fill out a 1099 for baseball but not for softball.

Vice Chairman Payne commented that there could be ramifications by the IRS if those 1099s aren't filed. Sue noted that it's their association that is not complying with the agreement and that is their responsibility; the only thing we can do is to not renew an agreement with them.

Secretary Mattocks asked if there is a means for immediate revocation of the lease agreement based on softball's non-compliance. Sue responded that it is a decision to be made by the Parks and Recreation Department and the Parks Board as to whether we want to interrupt the league because the association is not following through with the conditions of the agreement, which we can do.

Board Member Vickers stated that if we do decide to take action we need to give them one week to get some of this going or let them know that we will shut them down. Secretary Mattocks added that the intent is not to penalize citizens or the children, but the lease has to have some consequence to it or we will continue to get this.

Chairman Porter suggested making a motion to postpone this item until the next Parks Board meeting in September since the party in question is not in attendance.

Vice Chairman Payne motioned to table the review of the Moore Girls Softball Association until the next meeting; second by Board Member Vickers.

#### TERM ENDING DATES FOR CURRENT PARKS BOARD MEMBERS

Chairman Porter stated that he had heard that term limits to serve on the board had changed and with the information provided by Deidre Ebrey, Assistant City Manager, the board now knows exactly when everyone's terms end and we can look ahead for candidates as the current board members phase out. Secretary Mattocks added that moving forward we need to keep ward balance in mind for future candidates.

#### **NEW BUSINESS:**

#### (A) CITIZENS TO BE HEARD

Kacee Coberly, 2509 NE 16<sup>th</sup> St., gave an update on the Moore Youth Baseball Association since taking over at the beginning of the year. Tournaments got off to a small start but they were able to put money back in bank; 1099s were filed for their employees; and \$15,000 was spent on dirt for the ballpark. He said that commented they lost some umpires due to them having to file 1099s versus pay at the plate, but added that they didn't lose anyone of value and it keeps all the paperwork in line. There were 51 teams in the spring and 52 for fall. There were six Courage League teams to begin with, three older and three younger teams, and it's up to eight now so athletes get to play each other. There are still some small kinks to work out but by the time we're done in the fall they should be worked out.

Chairman Porter noted that he hasn't heard any complaints even though some of their tournaments were slow to make. Kacee responded that it was the MYBA board's decision on sanctioning; they elected to stay USSSA sanctioned. As a baseball coach I like USSSA because everything is black and white, but as a ballpark if you're tied to one sanctioning body anybody that's tied to that sanctioning body can play elsewhere and then you don't have anywhere else to draw from. Once we switched to non-sanctioned our first tournament had 53 teams and our second had 66; that was a good way to end the season.

Board Member Vickers commented that MYBA has worked hard to get back on track and thanked Kacee for his hard work. Secretary Mattocks noted the positive feedback she has been hearing and commended Kaycee for that. Chairman Porter thanked Kacee for the update.

#### (B) ITEMS FROM THE PARK BOARD

Secretary Mattocks stated that she and Board Member Vickers met with Amy Holland, a candidate for the Ward 2 Parks Board vacancy; Amy has a background in childcare and is the director of a childcare center. Board Member Vickers added that Amy would be an asset to the board due to her background working with younger children and their activities, which is something we don't usually deal with. Secretary Mattocks asked about making the recommendation to City Council to appoint Amy to the Parks Board. Sue responded that she was thinking of making it an agenda item for the next Parks Board meeting. Deidre suggested talking to the City Attorney about the vetting process and said that whichever way is decided upon, from then on. Board Member Vickers stated that he liked the process of current Parks Board members interviewing candidates for the board and making a recommendation instead of City Council just picking a person. Deidre noted that City Council would still have to approve whomever the Parks Board recommends, but the Parks Board can set up its own procedures for selecting a candidate.

Secretary Mattocks asked about the possibility of attending board meetings via Zoom or other means if not able to make it in person as that would help in having a quorum sometimes. Sue said she would look into it and get back to her.









# Projected Costs for FY 24-25 Automobile and General Liability



# Cost per \$1,000 Payroll at 7/1/24-25 Cost Level Automobile and General Liability







**Outstanding Losses:** The losses not yet paid. Equal to the difference between the ultimate losses and the paid losses. These are also equal to the sum of the case reserves and the IBNR reserves.

**Case Reserve**: Reserves established on individual claims by the case adjusters, as of the latest available evaluation. The case reserve plus the amount paid to date represents the adjuster's best estimate of the ultimate value of a particular claim.

**Reported Losses**: Paid losses plus case reserves as of the latest available evaluation.

**IBNR**: This is the dollar amount which we have estimated will be added to the reported losses between the date when the losses were compiled and final settlement of all claims for the accident period.

#### **DISCUSSION**

#### **Planning**

The subject site is located South of SW 19<sup>th</sup> St. and West of S Bryant Ave. and is currently zoned R-1 Single-Family residential. This Final Plat consists of 99 residential lots and approximately 7.71 acres of Common Area on 31.87 acres. This results in an overall density of 3.1 residential lots per acre.

Public water and sewer are available to the site and must be extended from the Broadmoore Heights Sec 2.

There is no FEMA regulated floodplain located on the subject site. The plat includes one common area with dedicated drainage areas for a retention pond on the west side and a detention pond on the east side. This section of the development backs up to the Broadmoore Addition along SE 34th. The lots at the South side have a common area open space buffer between this subdivision and the Broadmoore Addition.

Access is proposed by Warwick Way and Colt Way. The lots situated between Colt Way and Warwick Way are double-frontage and a Limits of No Access is required along the rear property line of those lots, with no curb cuts allowed to Warwick Way. Additionally, a temporary fire access was installed with the previous phase of development connecting Halley Drive to Willow-Pine Rd. This temporary connection was intended to provide emergency access, however it has become a regularly-traveled pathway for residents. To help ensure resident safety and access, this temporary connection must be made a permanent public street connection with this phase of development.

This portion of the Broadmoore Heights Addition is located in an area of historical drainage problems located both to the northeast in the Estelle's Country Club Estates and to the south along Broadmoore Addition, Section 1 abutting SE 34<sup>th</sup> Street. The proposed development intends to take the historic runoff from these areas into engineered flumes that flow into the Retention Pond D, which is designed to have a controlled release into an improved drainage flume that drains to the Broadway Avenue ROW. This plan is designed to reduce the amount of historic runoff to the Estell's County Club Estates and Broadmoore Section 1.

#### **Emergency Management**

There is one Common Area identified on the final plat that spans the Southern portion of the phase. Common Area H is intended for drainage infrastructure, and also contains an existing pipeline easement and will serve as a buffer to the existing homes in the Broadmoore Addition along SE 34<sup>th</sup>.

#### Water/Wastewater

No Comments.

#### **ENVISION MOORE 2040 COMPLIANCE**

The Envision Moore 2040 Plan calls for this location to be Urban Residential. Land uses allowed in the Urban Residential land use designation include a mix of single-family detached units up to 7 dwelling units per acre. This application was reviewed as to its conformance with the intent of the Plan.

**Quality Appearance and Amenities.** The plan places a large emphasis on quality design and appearance, focusing on increased landscaping, accessible open space, and access management. This final plat includes approx. 24% open space, and the preliminary plat provides over 15% open space overall, with the majority being detention ponds and drainage infrastructure

**Pedestrian-Oriented Design.** With this development being located within ¼ mile of the Broadmoore Elementary and ½ mile of Heritage Trails Elementary, pedestrian-oriented design is important. Sidewalks shall be included on all adjoining street ROWs to help ensure pedestrian integration into the neighborhoods and surrounding schools.

**Congestion Management.** The Plan promotes access management, internal street networks, and active transportation as a way to reduce traffic congestion. This phase of the development is accessed from Halley Dr that was installed with Broadmoore Heights Section 2. With this phase of Broadmoore Heights, a permanent roadway connection to Willow Pine is required.

**Stormwater Management.** The Plan calls for preserving natural resources as amenities for future residents while also accommodating development; floodplains, streams, and riparian areas are a priority for preservation. This phase of the Broadmoore Heights development is utilizing stormwater detention and retention ponds, acting as an amenity for the development.

Based on the proposed densities, stormwater amenities and open spaces, staff believes that this application meets the intent of the Urban Residential land use and the overall goals of the Plan. An amendment to the Plan is not required.


### **RECOMMENDATION**

Due to the compliance with the Preliminary Plat, Staff recommends approval of the final plat contingent upon the following:

- 1. Staff approval of all paving, drainage, sewer and water plans.
- 2. Staff approval of all street names, building lines, and easements. All front yard and corner lot utility easements shall be set back a minimum of 10' from the building line.
- 3. Fire Department approval of all fire hydrant locations.
- 4. Permanent roadway connection from Halley Drive to Willow Pine Drive is required.
- 5. Compliance with all development fees, including the Transportation Impact Fee and GIS Fee



# **DISCUSSION**

The subject site is located north of NW 12th St and east of I-35 in the Newmoor Addition neighborhood. The property is currently zoned R-2 and is developed with a residential house of approximately 1,220 sq ft with an attached 2 car garage. The applicant is proposing to rezone the property to a C-1 Office District to allow for future commercial use. No particular use of this lot has been identified.

Public water and sanitary sewer are available to serve the site. This site is not located in a floodplain and therefore a FEMA submittal will not be required. Because the lot is under 1 acre is size, no on-site detention is required.

The current lot includes driveway access from Sunrise Dr. To reduce congestion on NW 12<sup>th</sup> Street, no new driveways will be allowed along NW 12<sup>th</sup> Street in this location. Any new development must access the lot from Sunrise Dr.

The subject site is located in an established residential neighborhood with homes to the north and west, but along a major arterial road, NW 12<sup>th</sup> Street, and commercial zoning uses to the south and east. There is a precedent of a C-1 use on a previous residential lot to the west of this site, at 721 NW 12<sup>th</sup> Street, being an insurance office developed prior to 2000. However, that use utilized the residential structure as the office and does not conform with the commercial development requirements, such as an off-street parking lot, landscaping, etc.

The building envelope for the subject site is extremely small due to the platted easements, building line setbacks and parking requirements. With all setbacks accounted for, the lot allows for a maximum building width of 30' and maximum size of approximately 1800 sq ft, however all parking requirements must be met based on use, which may significantly decrease the maximum building size to meet city zoning requirements.

# **ENVISION MOORE 2040 COMPLIANCE**

The Envision Moore 2040 Plan calls for this location to be Urban Residential. Land uses allowed in Urban Residential include light commercial uses, including professional offices, only if the development is located along the periphery of the neighborhood and remains residential in nature (size and scope of business). This application was reviewed as to its conformance with the intent of the Plan.

Quality Appearance and Amenities. The plan values aesthetics and proper site design to enhance the quality of life of Moore residents. The goal "Strengthen Neighborhoods" (pg. 81) should be used as a guide in considering this application. Policy #1 under this goal is "Prevent Commercial Encroachment in Established Neighborhoods" and explains that any commercial encroachment erodes the fabric of the community and could result in poor relationships between uses and introduce incompatible activities, such as increased noise from customers or deliveries, light from exterior commercial lighting, excess parking and impervious surfaces, etc. Any redevelopment of the subject site would need to exclude these activities.

**Pedestrian-Oriented Design.** The Plan places a large emphasis on connecting residential and commercial developments with sidewalks and/or trail connections. An existing 6' sidewalk is already present along NW 12th Street and shall be maintained with any new development. Additionally, any new development or land use will be required to provide sidewalks along Sunrise Drive.

**Congestion Management.** The Plan recognizes the burden of roadway congestion on the quality of life within the city. Access to the subject lot will be limited to Sunrise Dr to prevent traffic congestion and conflicts along NW 12<sup>th</sup> street. Any new development will be required to provide off-street parking from the Sunrise Dr access point. It should be noted that the existing driveway could not be used to satisfy this requirement because of the backing movements onto Sunrise Drive.

**Stormwater Management.** The Plan calls for preserving natural resources as amenities for future residents while also accommodating development; floodplains, streams, and riparian areas are a priority for preservation. This site does not contain a FEMA-designated floodplain. Being less than 1-acre in size, on-site stormwater detention is not required; however, any new impervious surfaces would need to be designed to not affect the adjacent properties.

Being a part of the Newmoor Addition, this property falls under the Urban Residential land use category. Any new development must be designed to maintain the residential character of the neighborhood. This land use category discourages commercial encroachment into the neighborhood by establishing requirements for new commercial businesses, being: located on the edges of the neighborhood, buffering to protect the integrity of abutting residential uses, buildings that mimic residential structures, and minimal traffic, noise and odor impacts. It should be pointed out that only a Planned Unit Development would give certainty to future development plans and a thorough evaluation on the impact to the adjacent residential uses.

# **RECOMMENDATION**

This subject site is located in the Newmoor Addition, along NW 12<sup>th</sup> Street, a highly traveled and commercialized arterial roadway. The applicant wishes to only rezone the property at this time to sell as commercial and does not intend to develop the property. Although City Staff is not opposed in general terms to rezoning this site to C-1 commercial, there are some major concerns with this speculative rezoning application:

- Can the existing home be effectively used for a commercial use and still meet the commercial development requirements as set forth in City Code?
- Will the future use of the property conform to the recommendations set forth in the
  comprehensive plan to protect the integrity of the neighborhood? Buffering
  techniques used to protect abutting residential uses, minimal traffic generation, no
  noise or light trespass, no commercial activity after dark, limits on paved areas,
  and compatible building forms are important factors to consider.


> Will the property be able to be developed considering the extremely small building envelop available, or will further expansion into the neighborhood be required for a viable commercial site?

These are questions that are not able to be assessed using the development regulations in the City Code alone, but must be considered in concert with a specific development plan.

Due to the importance of protecting the integrity of surrounding residential uses within the Newmoor Addition and the uncertainty surrounding the speculative rezoning application, City Staff recommends denial of this application, and instead recommends the applicant reapply when a user is identified and utilize a Planned Unit Development to give certainty of neighborhood compatibility to the Planning Commission, City Council, and surrounding neighbors.

# **SECTION I - Duration of Agreement**

(A) The duration of this agreement shall be extended five (5) years from March 31, 1983, asadopted by the Board of Directors on that date.

# AMENDED AGREEMENT CREATING THE ASSOCIATION OF CENTRAL OKLAHOMA GOVERNMENTS

# **PREAMBLE**

WHEREAS the 30th Oklahoma Legislature enacted Title 74, O.S. {1971) § 1001 - 1008a permitting public agencies to enter into agreements with one another for joint or cooperative action pursuant to the provisions of said act; and

WHEREAS, pursuant thereto, it is the purpose and desire of the undersigned public agencies to create a Council of Governments to enable said public agencies to more efficiently use their powers by cooperating with each other on a basis of mutual advantage and thereby provide services and facilities in a manner and pursuant to a form that will accord best with geographic, economic, population, and other factors influencing the needs and development of said public agencies.

NOW, THEREFORE, the Association of Central Oklahoma Governments is hereby created by agreement of the parties hereto, under the authority of Title 74, O.S. (1971) § 1001 - 1008a, in accordance with the following provisions:

The Agreement For The Organization for the organization of Association of Central Oklahoma Governments, dated June 26, 1966, is hereby amended in its entirety to read as hereinafter provided.

#### **SECTION I**

# Duration of the Agreement and Organization Created Thereby

- (A) The duration of this the Agreement shall be and organization per a 1973 amendment was set for five (5) years from the effective date of approval by the appropriate approving officials. governing body making a recommendation of either continuing or ceasing the created organization. In 1983 the Board of Directors amended the Agreement to extend it and the organization another five (5) years from March 31, 1983. Hereafter, as amended, the term of the organization shall be from year to year without the necessity of a formal renewal by the Board of Directors, thereby making the duration of the amended Agreement perpetual.
- (B) The Board of Directors created pursuant to this Agreement shall review the Agreement and the entity organization created annually and make recommendations therefor. The same procedure concerning annual review by the Board of Directors shall be applied to the entity created at the end of the entity's fifth (5<sup>th</sup>) year of existence and recommend continuing or ceasing, at its own discretion and recommend amendments to the membership for ratification, when deemed necessary.
- (C) There is hereby created a third entity (organization) which shall be separate and apart from the signatory members hereto and shall owe its legal existence to this Agreement. Said entity shall be known as "Association of Central Oklahoma Governments," herein referred to as ACOG, and shall be a separate legal entity for the purposes that are set forth in this Agreement.
- (D) ACOG is a voluntary association with membership open to all units of general local government within the delineated Sub-State Planning Region 8, as established pursuant to Governor's Executive Order of May 21, 1971. Local governments outside of the Sub-State Planning Region 8 that share a mutual boundary with the region may become members of ACOG with the approval of the Board of Directors (refer to membership process below).
- (E) ACOG Membership:
  - (a) Units of local government may join ACOG by passage of an ordinance, resolution or otherwise, pursuant to law of the governing body of the unit of local government seeking membership and signing of this Agreement. Units of local Government joining ACOG shall be designated as "members."

The various attributes of membership concerning voting, dues and the like are detailed in Sections I and IV of this Agreement. Each respective local unit of government in the ACOG region and adjacent thereto, if approved by the Board, shall select its voting member to the association. They shall select not more than two (2) alternate members at least one (1) alternate member by the same process. Either of The alternate members may serve in the absence of the regular selected representative and have all the voting privileges and rights of the regular selected representative and such representative shall be a member of the governing Board of Directors.

Such appointment shall be in writing and shall specify the power or powers delegated thereto and shall be filed with the ACOG Board of Directors, duly signed by the appointing authority. Provided, however, such alternates shall be elected officials from the appropriate local unit of government or public agency.

(b) Board of Directors of ACOG, Creation and Selection:

There is hereby created a Board of Directors of ACOG which shall serve as the governing body of ACOG. Each <u>individual</u> member on the Board of Directors shall be designated as a "Director" and as such, shall have all the attributes of a Director as so stated in Article IV of this agreement.

The Board of Directors shall be selected as follows:

- (1) The Governing Board of each county that is a member of ACOG shall select one (1) member from the Board of County Commissioners who shall be designated as a Director.
- (2) The Governing Board of each member unit of local Government shall select one (1) member from such the respective Governing Board who shall be designated as a Director.

# (c) Associate Membership:

All other entities that fall outside of the category of units of local government but are within the definition of Public Agency as defined by the Interlocal Cooperation Act, Title 74 O.S. (1971) § 1001 - 1008a, shall be eligible for "Associate Membership" status in ACOG.

Those entities seeking membership in the Associate Member category shall pay a nominal membership fee, as established by the Board of Directors of ACOG, prior to being allotted membership in ACOG, Annual assessments shall be provided for as determined by the Board of Directors.

(d) Weighted Vote of Board of Directors:

Each Director representing a county member shall have two (2) votes for purposes of weighted voting.

Except as provided above, each Director shall have a weighted vote in accordance with the following schedule:

- (1) Each Director representing a total population of less than 75,000 shall have one (1) vote for each 2,500 population or fraction thereof.
- (2) Each Director representing a total population of more than 75,000 shall have the votes as provided in (1) above for the first 75,000 population and one (1) additional vote for each additional 7,000 population therein or fraction thereof.

## **SECTION II**

# **Functions and Purposes of ACOG**

- (A) The Association of Central Oklahoma Governments is organized as a forum for full and open discussion, study, and resolution of area wide problems of mutual interest and concern to its participating members.
- (B) The paramount function of the Association of Central Oklahoma Governments is to promote and enhance the cooperative identification of common issues, differences, and problems inthe physical, of the member governments, while targeting economic, social, and fiscal well-being of the region, its citizens, and business enterprises, and the coordinated resolution and implementation of policy matters and programs of action for the mutual interest of all.
- (C) To the maximum extent feasible, in carrying out the functions of ACOG, utilization of member staff resources is encouraged in order to minimize the duplication of effort, minimize costs, and draw upon the experience and expertise of members in order to promote and strengthen local capability to develop area wide cooperation and continuity.

- (D) The identification and determination of locally perceived issues, problems, and priorities requiring concerted coordinated action of a multi-jurisdictional nature.
- (E) The development and implementation of area wide goals, policies, and programs which provide for and enhance the individual and collective planning and development programs of member entities and the ACOG area.
- (F) To assist member entities with direct professional and technical services when requested and authorized, when such activities are compatible with ACOG's adopted work program and adequate resources are available.
- (G) To function as an Area Wide Coordinating Organization and as a regional clearinghouse for Federal or State Funds or Projects that are required by State or Federal Law or regulations to proceed through some formal review by an organization like ACOG and by virtue of initial certification and maintenance of a continuing, viable program of necessary area wide coordinating activities.
- (H) To perform any such other functions as the Board of Directors shall deem appropriate for ACOG. This shall include action by the Board of Directors on behalf of all or part of the membership to negotiate and consummate contractual agreements of mutual interest to concerned federal, state, and local governments.
- (I) To permit local governmental units to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities.
- (J) To provide a practical and organized means by which the public agencies within the ACOG area may cooperate and coordinate their activities as set forth herein to achieve maximum benefits and results.
- (K) To provide means and services for coordinating the individual and intergovernmental activities of and within the public agencies for the betterment of the ACOG area.

- (L) As approved by the Board of Directors, and in coordination with the Oklahoma State—
  Planning Agency, to prepare and develop an overall area wide comprehensive development program, and revisions and updating thereof, for long range growth, which programs include, but are not limited to, adequate land use, housing, open space, public utilities, transportation, and economic planning, and contain a specific programs for district cooperation, self-help initiatives, and the strategic investment of public resources, both financial and human.
- (M) To coordinate a program for planning and development in order to improve the physical, economic, social, and environmental conditions in the region.
- (N) To carry out such research, planning, and advisory functions as are required by the Board of Directors.
- (0) To render such non-financial assistance to its member governmental units as is within the scope and range of its activities and purposes.
- (P) To facilitate cooperation and coordination of activities with Federal and State Agencies, as well as Regional Partners, having responsibility for planning and developing natural, human, and physical resources of the region, as well as planning, legislative, or executive authorities of neighboring states, regions, counties, or municipalities.

# SECTION III Board of Directors

The Board of Directors shall be the governing board of ACOG. A quorum as per Section IV (D) of the Board of Directors shall be solely responsible for the specific policies of ACOG, and for the administration of all its funds. It shall have the power to administer all funds and property of ACOG as it deems necessary or appropriate. The Board of Directors of ACOG shall have the power to promulgate and adopt any such Bylaws as deemed appropriate. It shall have the sole power to employ the Executive Director. The Board shall have the authority to rent office space and/or purchase real property for ACOG staff operations, and purchase such services, equipment and/or supplies as may be deemed necessary to conduct the business of ACOG in accordance with the organization's adopted Procurement Policy.

## **SECTION IV**

# Financing of the **Entity Created** Organization

The financing of the joint undertaking contemplated by this Agreement and the organization created thereby shall be accomplished in the following manner:

- (A) The financing of the ACOG basic assessment shall be in direct proportion to the total weighted vote of each Director on the Board of Directors, in accordance with Section I.

  Assessments for other activities shall be determined by the Board of Directors.
- (B) All financing shall be as follows: The budget shall include the required amount of funds needed to operate ACOG for one (1) fiscal year. This amount shall be financed as provided above.
- (C) In April of each year prior to budget and assessment schedule recommendations—in May, the ACOG staff will submit to the Board of Directors for its adoption, an estimate of population of Sub-State Planning Region 8 and the members of ACOG therein and members adjacent to the region, which shall serve, when adopted, as the determination of population for representation and assessment purposes. The larger most recent numerical population reflected by either the Oklahoma Employment Security Commission's most recent final population projects, or the estimates provided by the U.S. Bureau of the Census Special Count population statistics for each ACOG member shall be used by the ACOG staff in submitting population estimates for adoption. Any change in the weighted vote provisions of Section I (E) (d) hereof necessitated by the above provisions pertaining to population counts shall become effective on the immediately following July 1 of the then-current year.
- (D) Directors representing in excess of 50% a majority (more than 50 percent) of the total weighted vote of the Board of Directors shall constitute a meeting of the Board of Directors requiring compliance with the Oklahoma Open Meeting Act. Directors representing a majority of the total weighted votes of the Board of Directors and representing a minimum of six (6) member entities present shall constitute a quorum necessary for the transaction of business. A quorum shall consist of twelve (12) entities present.
- (E) In transacting the business of the Board of Directors, all questions must receive a minimum vote in excess of 50% of more than 50 percent of the total weighted vote representing six (6) entities or more of the Board of Directors to pass.

- (F) All official votes cast in the conduct of the business of the Board of Directors shall be subject to roll call vote on the request of any Director.
- (G) The Board of Directors shall elect a Chairman, Vice-Chairman and Secretary-Treasurer

  Secretary/Treasurer. The officers of the Board of Directors shall be elected at the regular

  May meeting of each year. Such officers shall hold office for one-year terms, or until their
  successors shall be elected and qualified. No officer may succeed himself/herself in more
  than one consecutive term.
- (H) The Board of Directors may hold its meetings and keep the books of the Board at such place as it may from time to time determine. shall delegate to ACOG the responsibility of keeping correct and complete books and records of accounts, and meeting minutes of the Board of Directors at the principal office of the organization.
- (I) The Board of Directors shall appoint, fix salary of and remove the employ an Executive

  Director to direct report to the Board of Directors, who shall serve at the pleasure of the

  Board. The Executive Director's compensation shall be approved by the Board of Directors.
- (J) The Board of Directors shall have sole authority to initiate and review all planning activities, grants and contracts, and shall adopt or approve any study or plans. be responsible for the review, approval, and adoption of regional plans, programs, and initiatives, and of all ACOG policy documents, including but not limited to an annual budget and work plan, strategic/implementation plans, annual work programs, annual independent audit, and personnel policies.
- (K) The Board may establish standing and ad hoc policy and administrative, management, and technical advisory committees as it deems necessary and helpful to the exercise of its responsibilities under this Agreement. These committees shall include but are not limited to the Executive Committee, Nomination Committee, Budget Committee, Building Review Committee, and the Agreement & Bylaws Committee.
- (L) The Board may also create and appoint sub-committees from the Directors to sub-committees.
- (M) Should a vacancy occur in the members of the Board of Directors, a successor shall be selected by the original appointing authority or authorities.

- (N) All Directors of the Board of Directors shall serve without compensation, but may be reimbursed for actual expenses incurred in the performance of their official duties upon the approval of such expenses by the Board of Directors.
- (0) The Board of Directors, solely, is through ACOG empowered to receive and expend all grants, gifts, and bequests, specifically including Federal and State funds and other funds available for the purposes for which this organization exists, and to contract with the United States, State of Oklahoma, and all other legal entities with respect thereto.
- (P) Dues are assessed and payable July 1 each year. Voting privileges are forfeited upon non-payment of dues within 120 days of July 1.

# SECTION V Meetings of the Board of Directors

- (A) The Board of Directors shall meet monthly, except for the month of July. Written notice of such meetings and the business to be transacted thereat shall be served upon or mailed to each member of the Board at least seven (7) days prior to the meeting. all regular monthly meetings shall be in compliance with the requirements of the Oklahoma Open Meeting Act and provided to each voting member. An agenda shall be required for such meetings. All meetings of the Board of Directors shall be held at the principal ACOG office or at other locations, if deemed necessary, within the ACOG region.
- (B) Special meetings of the Board may be called by the Chairmanperson upon three (3) daysnotice to each Board member, either by special delivery mail or by telegram. with notice
  in compliance with the requirements of the Oklahoma Open Meeting Act and delivered as
  written notice to all voting members. Special meetings shall be called by the
  Chairmanperson in a like manner and on like notice upon the written request upon
  written demand of five (5) Board members. The notice of all special meetings of the
  Board shall include a written statement of the purposes of the special meeting and
  business of such meeting shall be restricted thereto. Only the specific item(s) of business
  specified in the notice for special meetings shall be conducted at such meeting. Such
  meetings shall be held at the principal ACOG office or at other locations, if deemed
  necessary, within the ACOG region.

(C) All meetings of the Board of Directors of ACOG will be held under the guidance of and pursuant to the public meeting laws of the State of Oklahoma. shall be conducted in compliance with applicable State Law.

# SECTION VI Notices

Whenever any notice is required to be given under the provisions of the Agreement to any member, a waiver thereof in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent thereto.

# SECTION VII Executive Director

The Executive Director shall be the Chief Administrative Officer of ACOG. The powers and duties of the Executive Officer Director are:

- (A) To appoint, supervise, and remove all employees of ACOG.
- (B) Annually to prepare and present a proposed budget and work plan to the Board of Directors and to administer an approved budget and work plan, subject to dictates and powers of the Board of Directors thereof.
- (C) Authorized to sign and execute contracts on behalf of ACOG in accordance with the adopted Procurement Policy.
- (D) Acts for and represents the Board of Directors in all ACOG public engagements and media requests, and shall direct day-to-day operations for the agency.
- (E) To perform such other additional duties as the Board of Directors may require.

# SECTION VIII

# **Amendment of Agreement**

This Agreement may be altered, amended, or otherwise modified pursuant to a majority upon a vote representing more than 50 percent of the total weighted vote of a quorum of the Board of Directors representing a minimum of six (6) entities or more present, at any meeting, provided that such amendment, alteration, or modification shall have to be ratified by a majority of the members governments, and approved by the Attorney General prior to it becoming effective.

# **SECTION IX**

#### Dissolution

- (A) Dissolution of the ACOG shall be affected upon a vote representing in excess of 50% more than 50 percent of the total weighted vote of a quorum of the Board of Directors representing a minimum of six (6) entities or more present, provided that such action shall be ratified by a majority of the member governments and approved by the Attorney General prior to becoming effective.
- (B) Upon dissolution or final liquidation of the ACOG, after discharge or satisfaction of all outstanding obligations and liabilities, the remaining assets, if any, of ACOG shall be distributed to the members in the same proportion to which each member contributed to in the form of dues, assessments to the overall cost of the operations of the ACOG during the fiscal year of such dissolution or final liquidation.

# SECTION X

# Withdrawal of Membership

Any member may withdraw from the Association by passage of a resolution of its elected governing body terminating its membership under the interlocal agreement establishing ACOG.

# SECTION XI Effective Date

This Agreement shall become effective and final upon approval of the Attorney General of Oklahoma, and other appropriate officials with statutory or constitutional powers over this Agreement, and shall remain in full force and effect until the organization is dissolved under the provisions of Section IX or terminated as herein provided.

# SECTION XII Execution

This Agreement may be executed in multiple counterparts by each unit of local government party hereto, and each such copy shall be executed by the chief elected executive officer of each such member unit of local government, attested and sealed by the clerk thereof, pursuant to the proper adoption and execution of a Resolution of the governing board of the respective units of local government, to which a copy of this Agreement is affixed and of

which it forms a part, and all such multiple counterparts shall together be considered as one and the same Agreement.

# AMENDMENT No. 1 TO PROJECT AGREEMENT 33025(04)(05) BETWEEN OKLAHOMA DEPARTMENT OF TRANSPORTATION, BNSF RAILWAY COMPANY AND THE CITY OF MOORE

This Amendment represents a modification to the original Project Agreement for Job Piece No. 33025(04)(05) between the City of Moore (CITY), BNSF Railway Company (BNSF) and the Oklahoma Department of Transportation (DEPARTMENT) dated March 18th, 2021 Pursuant to Section 7 of the original Project Agreement, the terms of the original Project Agreement are modified in this Amendment No. 1. Therefore, the parties mutually agree to the amendments stated below.

A. Section 5 of the Project Agreement is amended as follows:

#### SECTION 5 CONSTRUCTION FUNDING

- **5.1** The total estimated construction cost is now \$39,997,110.52. A RAISE Grant in the amount of \$10,000,000 and \$5,000,000 of Congressionally Directed Spending will be applied to the construction cost. Resulting in a remaining balance of **\$24,997,110.50**. The remaining balance will be split 50% to be provided by the **DEPARTMENT** and 50% to be provided by the **CITY**.
- **5.2** The total estimated BNSF Force Account cost is \$8,004,623.00. This balance will be split 50% to be provided by the **DEPARTMENT** and 50% to be provided by the **CITY**.
- **5.3** In the event of a Federal Grant award, the grant funding will be split by the **DEPARTMENT** and the **CITY** per the funding split per section 5.1.

**IN WITNESS WHEREOF**, the Deputy Director of the **DEPARTMENT** or designee, pursuant to the authority vested by the Transportation Commission, has hereunto subscribed his name as Deputy Director of the **DEPARTMENT** and the **CITY and BNSF** have each severally executed same pursuant to authority prescribed by law on the date of the last signature on the agreement modification.

Resolution No. 96(24) authorizing the City of Moore to submit a grant application to the Oklahoma 9-1-1 Management Authority for the implementation of the Emergency Police Dispatch Protocol system.

## **Background**

Across the State of Oklahoma, the quality of 9-1-1 services varies greatly. In order to provide more uniform, high quality 9-1-1 service statewide, the Oklahoma 9-1-1 Management Authority has created a grant program to assist local jurisdictions with funding. One of the eligible projects that qualify for funding is call taker training and certification, 9-1-1 administrator training, and Protocols, including necessary hardware and software.

#### **Discussion:**

The City of Moore is completing an application for the implementation of the Emergency Police Dispatch Protocol system. This system is a set of dispatch protocols used by dispatchers in handling emergency calls for service. The use of these protocols ensures consistent training of all dispatchers. To use the protocols dispatchers will be required to complete a class and receive a certification. Dispatchers will also be required to re-certify every two years. Moore already uses the protocol system for medical and fire calls, therefore, implementing the police protocols would complete the protocol system set. The protocols work together with one another, making call handling solutions more efficient and consistent.

#### Recommendation:

Staff recommends City Council approval of Resolution No. 96(24) authorizing the City of Moore to submit an application to the Oklahoma 9-1-1 Management Authority for the implementation of the Emergency Police Dispatch Protocol system.

# **RESOLUTION 96(24)**

# GENERAL DESCRIPTION OF POSITION

Perform screening functions at the Moore Municipal Court, located in the Moore Public Safety Center, during designated hours to maintain a safe environment for the public and employees to conduct government activities. Under direction, operates screening equipment such as walk-through units and handheld metal detectors. Will occasionally report disturbances, hazards, and suspicious persons and activities to the proper authority.

## ESSENTIAL DUTIES AND RESPONSIBILITIES

- 1. Maintain the safety and security of court visitors, judges, judicial staff, court employees, and the general public conducting governmental activities and business.
- 2. Provide security and maintain order.
- 3. Conduct screening of persons and properties entering the court facilities.
- 4. Redirect traffic flow, assist victims, and aid in incident resolution.
- 5. Record daily activities as necessary and submit related reports and paperwork through the appropriate chain of command.
- 6. Good attendance is required. This duty is performed daily.
- 7. Works in a manner safe to the individual and other people; keeps work area clean and safe; follows safety rules and safe work practices; uses safety equipment as required. This duty is performed daily.
- 8. Confidentiality is required upon specific notification to the employee. This duty is performed as needed.
- 9. Perform any other related duties as required or assigned.

# INITIATIVE AND INGENUITY

# SUPERVISION RECEIVED

Under direction where a definite objective is set up and the employee plans and arranges their own work, referring only unusual or extremely complex cases to the supervisor.

## **PLANNING**

Considerable responsibility with regard to general assignments in planning time, method, manner, and/or sequence of performance of own work; may also occasionally assist in the planning of work assignments performed by others within a limited area of operation.

# **DECISION MAKING**

Performs work operations that permit frequent opportunity for decision-making of minor importance and also frequent opportunity for decision-making of major importance; the latter of which would affect the work operations of other employees and/or clientele to a moderate degree.

# MENTAL DEMAND

Close mental demand. Operations requiring close and continuous attention for control of operations. Operations requiring intermittent direct thinking to determine or select the most applicable way of handling situations regarding the organization's administration and operations; also to determine or select material and equipment where highly variable sequences are involved.

# ANALYTICAL ABILITY / PROBLEM-SOLVING

Moderately structured. Fairly broad activities using moderately structured procedures with only generally guided supervision. Interpolation of learned things in somewhat varied situations.

# SUPERVISORY RESPONSIBILITIES

Does not supervise.

# RESPONSIBILITY FOR FUNDS, PROPERTY and EQUIPMENT

Occasionally responsible for organization's property where carelessness, error, or misappropriation would result in moderate damage or moderate monetary loss to the organization. The total value for the above would range from \$5,000 to \$150,000.

## **ACCURACY**

Probable errors would not likely be detected until they reached another department, office or patron, and would then require considerable time and effort to correct the situation. Frequently, possibility of error that would affect the organization's prestige and relationship with the public to a limited extent, but where succeeding operations or supervision would normally preclude the possibility of a serious situation arising as a result of the error or decision.

Generally controlled. General processes covered by established policies and standards with supervisory oversight.

None. Job does not create any dollar monetary impact for the organization.

Moderate impact. Job has a definite impact on the organization's end results. Participates with others in taking action for a department and/or total organization.

## **PUBLIC CONTACT**

Constant contact with patrons where the contact is initiated by the employee. Involves both furnishing and obtaining information and, also, attempting to influence the decisions of those persons contacted. Contacts of considerable importance and of such nature, that failure to exercise proper judgment may result in important tangible or intangible losses to the organization.

# EMPLOYEE CONTACT

Contacts with other departments or offices and also frequently with individuals in middle level positions; consulting on problems which necessitate judgment and tact in presentation to obtain cooperation or approval of action to be taken. Also, important contacts with associates.

Moderate diversity, moderately physical. Work activities allow for a moderate amount of diversity in the performance of tasks that require somewhat diversified physical demands of the employee.

While performing the functions of this job, the employee is regularly required to sit, talk or hear; frequently required to stand, walk; and occasionally required to use hands to finger, handle, or feel, reach with hands and arms, climb or balance, stoop, kneel, crouch, or crawl. The employee must occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include close vision; distance vision; color vision; peripheral vision; depth perception; and the ability to adjust focus. The employee may be required to take offensive and/or defensive action during physical confrontations and have the ability to discharge a firearm.

- Possession of a certificate by reciprocity issued by CLEET in accordance with 390:10-1-6 of the Oklahoma Administrative Code.

**NOTE:** Before a final offer of employment can be made, applicants must successfully pass a criminal background check and pre-employment drug screen.

## WORKING CONDITIONS

Employee must lift items such as supply boxes. Requires vertically transferring items weighing up to ten (10) pounds.

Employee must carry supplies from one location to another. Requires horizontally transferring items weighing up to ten (10) pounds.

Employee must sit at a workstation for periods of time. Requires tolerance of seated posture for prolonged periods.

Employee must operate a keyboard. Requires use of hands and fingers for inputting information into a computer system.

Employee must view a computer screen. Requires use of eyes to read computer screen continuously throughout the day.

Employee will spend a majority of time during court days standing, walking, and making observations of those in attendance in order to maintain a safe court environment.
