Said Resolution was thereupon signed by the Mayor, attested by the Clerk, sealed with the seal of said municipality, and is as follows:

RESOLUTION NO. 836(15)

RESOLUTION FIXING THE AMOUNT OF BONDS TO MATURE EACH YEAR, FIXING THE TIME AND PLACE THE BONDS ARE TO BE SOLD AND AUTHORIZING THE CLERK TO GIVE NOTICE OF SAID SALE AS REQUIRED BY LAW.

WHEREAS, the issuance of \$25,100,000 of general obligation bonds to provide funds for the purpose of acquiring, constructing and equipping various parks and recreational facilities within the City of Moore, Oklahoma, was duly authorized at a special election held for that purpose on the 6^{th} day of November, 2012; and

WHEREAS, as shown by the Canvass of Returns by the County Election Board, a lawful majority of the qualified voters voting at said election cast their ballots in favor of the issuance of said bonds and the issuance thereof has been duly authorized; and

WHEREAS, of the authorized \$25,100,000, the City Council of the City of Moore, Oklahoma, has previously issued its: (i) \$6,325,000 General Obligation Bonds of 2013B, dated March 1, 2013; (ii) \$9,075,000 General Obligation Bonds of 2014, dated January 1, 2014; and (iii) \$4,125,000 General Obligation Bonds of 2015, dated March 1, 2015; and

WHEREAS, the City Council of the City of Moore, Oklahoma, has determined that \$2,805,000 of the authorized \$25,100,000 amount should be issued at this time to provide funds to fulfill the purpose for which the bonds were voted.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MOORE, OKLAHOMA:

SECTION 1. That the \$2,805,000 of General Obligation Bonds of 2016, dated February 1, 2016 (the "Bonds"), of the City of Moore, Oklahoma (the "City"), voted on the 6th day of November, 2012, shall be offered for sale at the City Hall of said City located at 301 North Broadway, Moore, Oklahoma on the 19th day of January, 2016. The City will receive bids until 2:00 o'clock p.m. and said Bonds shall be awarded at 6:30 o'clock p.m., and that said Bonds shall become due \$255,000 on February 1, 2018 and \$255,000 annually each year thereafter until paid.

SECTION 2. That the City Clerk is hereby ordered to cause Notice of Sale of said Bonds to be published as required by law.
