RECEIVE AND APPROVE THE MINUTES FROM THE REGULAR MEETING HELD FEBRUARY 7th, 2023

Board Member Milum motioned to approve the minutes from the regular meeting held February 7th, 2023; second by Secretary Payne. Motion passed unanimously.

MAKE A RECOMMENDATION ON MOORE YOUTH BASEBALL ASSOCIATION AGREEMENT

Sue Wood, Parks and Recreation Director, stated that all of the sports association agreements will run from April 1, 2023 through March 31, 2024. She noted that Brooks Mitchell, City Manager, added a paragraph to the MYBA agreement stating that they will

make a payment of \$20,000 on or before November 15, 2023 as their first payment towards the new restrooms at Buck Thomas Park. She also stated that we are still looking at making adjustments to the construction to bring the cost down.

Board Member Vickers asked if there is a way to build around the utilities instead of moving them.

Whitney Wathen, Assistant Parks and Recreation Director, replied that they would try not to move the utilities as much to cut down on costs. He added that they could possibly eliminate one stall to make the building smaller and see what that cost savings might be at no additional charge from the architect.

Barry Williams, 1061 NW 6th Street, addressed the Board regarding Section 11, Safety Rules, in the MYBA agreement. He stated that relying on the 30/30 flash to bang ratio for lightning detection during severe weather needs to be updated and it should be added to the agreement that some type of lightning detection system be purchased to go along with the 30/30 to ensure that everybody is safe out on the fields.

Whitney Wathen, Assistant Parks and Recreation Director, responded that we are already looking at different options for lightning/weather alert systems and will share the information with the associations once we decide what to purchase.

Board Member Vickers motioned to amend Section 11, Safety Rules, in the agreement to state that all associations are required to have a device and system for monitoring weather conditions and lightning detection within a minimum ten-mile radius of all sports activities; this will also cover all four sports agreements; second by Secretary Payne.

Mr. Williams's suggestion is to open the north and south gates as well during tournaments or have the Moore Police Department start issuing tickets.

Whitney responded that opening extra gates during tournaments can be arranged; he also stated that "No Parking" signs can be put up and MPD will be contacted regarding this issue.
