Barbara Johnson, 205 S. Olde Bridge Road, stated that the Olde Stonebridge addition had been experiencing flooding issues. Ms. Johnson asked if the City had researched the effects of stormwater runoff from Cleveland Heights into Old Stonebridge. Brooks Mitchell, Executive Director, advised that the City would look into the situation and provide an update to the HOA.

Mike Galier, 3706 NE 12th, stated that he owns rental property in Cleveland Heights. Mr. Galier indicated that he also owns 75% of the water district along with Don Blue who owns the remaining 25%. He felt that the appraisal obtained by MURA did not take into consideration the value of the water system or their right to distribute the water. Mr. Galier indicated that they would seek legal representation if an agreement cannot be reached regarding the value of the property.
